On Tuesday, June 26th, the Littleton Police Department, Bethlehem Police Department, Franconia Police Department, Sugar Hill Police Department, Lisbon Police Department, Haverhill Police Department, Bath Police Department, Grafton County Sheriff's Office, DEA, Homeland Security Investigations, Attorney General's Drug Task Force, and the New Hampshire State Police (comprised of members from the Mobile Enforcement Team (MET), Narcotics Investigations Unit (NIU), and Troop F) participated in Operation Northern Alliance, a collaborative effort within northern Grafton County. The goal of this operation was to investigate and arrest individuals in New Hampshire distributing heroin, fentanyl and opioid-based narcotics along with other illicit drugs. In addition, this task force apprehend individuals who were wanted for non-drug related offenses.

As a result of this operation the following individuals have been arrested:

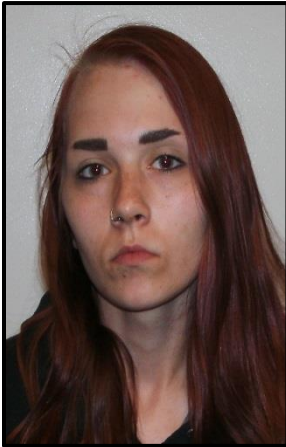

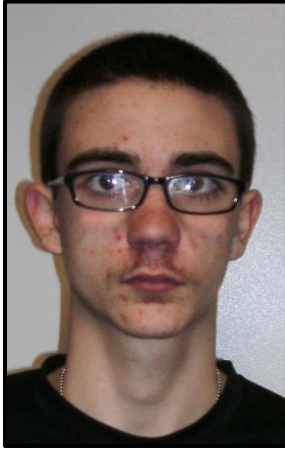

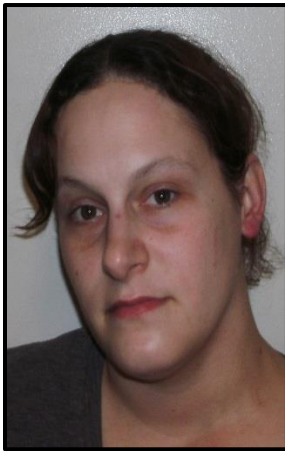

Felony- Superior Court Capias for Failure to Appear (original offense was Aggravated DUI -accident resulting with serious injury resulting).

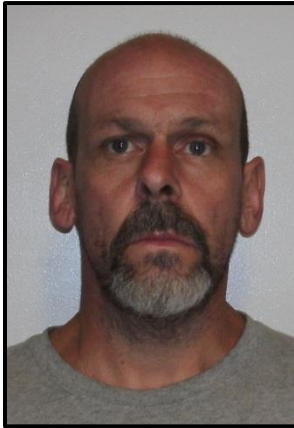

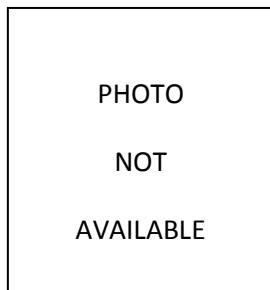

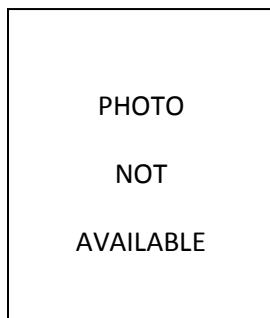
